Scholarship Program

MOV MNT Dance Company Scholarships

- Scholarships will be awarded each year with the value totaling three full scholarships (\$2,700) per company.
- Scholarship funds may be distributed in the form of full, half, or partial tuition awards.

Acceptance into the MDC scholarship program is by audition only. To be eligible for this program, students must be at least 6 years of age.

Auditions are held once each year with rehearsals beginning one week following the audition. Scholarship recipients are required to attend at least one weekly Company Class and all rehearsals set forth by MOV MNT Dance Company.

The full tuition value of this program is \$900, of which \$825 is provided by the scholarship award. The participant is responsible to pay a tuition fee of \$75 that is due upon commencement of the program.

The tuition fee goes directly to the program for education and performance expenses.

Considerations for scholarships include: financial need, commitment, attitude, level of participation in dance in the community, leadership qualities, and dependability.

SECTION III ELIGIBILITY

1. Must be 6 years of age or older by June 13, 2010.
2. Must participate in a weekly Company Class and be available for all company rehearsals and performances.
3. Pay Company dues, as applicable, on the 1st Sunday of each month beginning June 13, 2009.
4. Company members that are still in Middle School or High School must maintain a 2.5 GPA to remain a member of MOvMNT Dance Company.

6. Should the participant fail to meet the standards and policies set by MDC, after a warning, MDC may terminate the scholarship.
7. Recipient agrees to the use of their name and non-specific demographic information in news releases and promotional information about the award and experience.
7. By your signature on the application form, you acknowledge that you have received and understand the details of the award as well as the requirements and policies.
8. Please provide two references with application. These references may, at the discretion of the Scholarship Committee, be contacted to attest to your accomplishments in your academic, employment, or service endeavors or for further information about your application.

SECTION IV CLASSES

1. By choosing to be a member of MOvMNT Dance Company you will be obligated to take Company Class and participate in the appropriate company rehearsal every Sunday.

SECTION V CONFLICTS

1. MOvMNT Dance Company understands that circumstances arise that conflict with rehearsals and performances. It is your responsibility to inform the Artistic Director if you will be absent for any reason.
